

Pursuant to Regulation 30 of SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015 read with SEBI Circular SEBI/HO/CFD/CMD 1/CIR/P/2020/84 dated 20<sup>th</sup> May 2020, all the stakeholders are hereby informed that due to outbreak of the COVID-19 Pandemic the company closed its office from 18<sup>th</sup> March, 2020 after our Hon'ble Prime Minister announced National Lockdown in order to ensure the safety and well being of our employees and to comply with the various guidelines issued by the Central Government, State Government and the Local Administrative Authorities.

However in view of the lock down across the whole country the company has already complied with the policy of work from home for all its employees with effect from the aforesaid date. In operations the company is focusing on Social Distancing and hygienic practices for the safety of people.

As for now the company has estimated the turnover loss of Rs. 5,00,000 to apply till the end of the June Quarter and the probable loss of turnover of Rs. 5,00,000 to apply in the September Quarter due to the lockdown effected by the Government due to the pandemic.


As the pandemic has also affected severely, the normal operations can be put in operations from 1<sup>st</sup> October 2020 and onwards as per the estimates of the company.

Seeing the severe damage caused by the countrywide lockdown due to COVID-19 pandemic the company is planning to restart its operations from 1<sup>st</sup> October, 2020 after the damages are fixed.

Hence the company is planning to restart the operations probably from 1<sup>st</sup> October 2020 once the damage gets fixed.

In order to ensure the smooth functioning of the operations during this period of worldwide lockdown, the country has already taken the steps to provide the facility to work from home to all its employees.
