**COPENHAGEN:** Denmark said on Friday that a temporary ban on mink breeding will expire on January 1, allowing mink production to resume but at a "significantly reduced" level than before the coronavirus pandemic. The government two years ago ordered a cull of millions of minks and banned their farming to minimise risk of the mammals retransmitting the virus.

## 7 killed in minibus accident in Nepal

KATHMANDU: A 25-year-old Indian was among seven people killed when the minibus they were travelling in met with an accident in Nepal's Bagmati province, police said on Friday. The accident happened when the bus heading towards Birgunj from Kathmandu overturned at a steep turning point in Jurikhet in Bagmati's Makawanpur district on Thursday. The Indian national — identified as Sharan Narayan Sharma, a resident of Motihari in Bihar — died on the spot.

## **US** aircraft carrier arrives in S Korea



**SEOUL:** A nuclear-powered US aircraft carrier arrived in South Korea on Friday for its first combined drills after five years, as Washington and Seoul are striving to reinforce deterrence against evolving North Korean military threats. The USS Ronald Reagan docked at ROK Fleet Command in Busan, 390 km south of Seoul, amid worries about the possibility of the North staging a nuclear test or other provocations, reports Yonhap News Agency.

# Occupied parts of Ukraine vote in 'sham' referendum

KYIV: Voting began on Friday in Moscow-held regions of Ukraine on referendums to become part of Russia, Russian-backed officials there said.

The Kremlin-orchestrated referendums, which have been widely denounced by Ukraine and the West as shams without any legal force, are seen as a step toward annexing the territories by Russia.

The votes are being held in the Luhansk, Kherson and partly Russian-controlled Zaporizhzhia and Donetsk regions.

The vote, which asks residents if they want their regions to be part of Russia, is certain to go Moscow's way. That would give Russia the pretext to claim that attempts by Ukrainian forces to regain control are attacks on Russia itself, dramatically escalating the sevenmonth war.

The referendums follow Russian President Vladimir Putin's order of a partial mobilisation, which could add about 300,000 Russian

## UN rights experts present evidence of war crimes

**GENEVA:** A team of experts commissioned by the UN's top human rights body to look into rights violations in Ukraine said on Friday its initial investigation turned up evidence of war crimes in the country following Russia's invasion nearly seven months ago.

The experts from the Commission of Inquiry on Ukraine, mandated by Human Rights Council earlier this year, have so far focused on Kviv. Chernihiv. Kharkiv and

Sumy. Presenting their most extensive findings so far, they cited testimonies by former detainees of beatings, electric shocks and forced nudity in Russian detention facilities, and expressed grave concerns about executions in the four regions. "We were struck by the large

and settlements," Erik Mose,

## 60 dead after migrant boat sinks

**BEIRUT:** The death toll from a boat carrying migrants from Lebanon that sank in Syrian waters has risen to 60, the governor of Syria's coastal province of Tartus said on Friday. Abdul- Halim Khalil told the pro-government Sham FM that search is ongoing for more bodies off his country's coast. Thousands of Lebanese, Syrians and Palestinians have left Lebanon on boats over the past months seeking better opportunities in Europe. Khalil said the boat sank two days earlier.





## **Booker Prize winner Hilary Mantel dies at 70**

Ben Hamilton, who was

**LONDON:** Hilary Mantel, the British author of the best-selling Wolf Hall trilogy and the first woman to win the prestigious Booker Prize twice, has died. She was 70.

Mantel, regarded as one of the greatest English-language novelists of this century, died "suddenly yet peacefully" on Thursday surrounded by close family and friends, according to her agent.

A statement by publishers HarperCollins said: "We are heartbroken at the death of our beloved author, Dame Hilary Mantel, and our thoughts are with her friends and family, especially her husband." Born on July 6, 1952, in

Glossop, Derbyshire, Man-

tel received the prestigious Booker twice, for 2009's Wolf Hall, the first in the Thomas Cromwell series, and the 2012 follow-up Bring Up the Bodies, which also won the 2012 Costa Book of the Year. To date, the Wolf Hall trilogy has been translated into 41 languages with over five mil-

lion sales worldwide.


